6. ADMINISTRATION/STAFF REPORTS

6.1. & 6.2 Manager/Office Report -By Mardi Befort

- We had 6 blue stakes as of today.
- On Friday, October 14 we discovered the solenoid valve on the Lower Goodwin tank was closed not
 allowing the tank to fill. This valve is electrically controlled, and the breaker popped. Resulting in
 portions of Oak Hills to have low water pressure or no water. We have put in extra steps in our daily
 rounds routine to prevent this from happening again.
- The tank in Poland Junction has 4 leaks. Superior Tanks came out Tuesday to look at the leaks, and do a visual inspection of the tank. He was able to tighten the bolts and stop the leaks, he feels the tank is still in good condition with minimal rehab needed.
- I have not been able to replace the gravel in the customers driveway that was washed away from the leak last month, because Big Bug Sand and Gravel (BBS&G) is out of stock on that specific size and color of gravel. I have been in communication with the customer, and he understands the situation and is willing to wait.
- I hired a field tech/backhoe operator October 20, Monday was his first day.
- We have 2 areas that are needing asphalt patches. We are required to buy a minimum amount of asphalt which is more than we need for both patches. We have been in communication with the County

regarding this and they are aware of our situation and are working with us. This coming week the guys will level out the current patch on Fairland.

• Oakhills update:

• Frank will be coming out to help me get the Approval of Construction (AOC) completed, the final step is to get pressure tests in 2 areas at the same time.

Racetrack well:

- O There are no updates for the Racetrack well, but it was suggested that I look into USDA grants to get this finished as they are forgiving significant amounts of the loan portions of the grants right now. I will look into this and bring it to the Board with details if this is viable option.
- Water Turn Off's/Past Due Account.
 - October there were 16 shut offs. 2 are still off. One by choice, one person has not contacted us yet.
 - We sent out 64 past due bills this month.

Website usage

In the past 30 days our website has had 352 views (refers to the number of times the website has been visited) and 209 unique visits (Actual number of people who have visited the website).
 Example: if a customer goes onto our website 10 times in 1 day it will show there are 10 views and 1 unique view.

Water usage this month

- o This month it took us 2 days to read meters.
- o We pumped 2.51 million gallons, 280,000 gallons less than last month.
- o We sold 2.31 million gallons of water this month which is 60,000 gallons less than last month.
- o This month we had a water loss of 7.83% compared to 15.13% last month.
- O We have 3 meters with high reads this month that is not typical usage for them, 2 were over 60,000 gallons. With one over 90,000 gallons. The one with the higher read was also high last month. Carla and I have both spoken with the customer and suggested they look for a leak as the meter was turning.
- One of the high leaks last month which was over 80,000 gallons of water turned out to be a toilet leak.
- o 34 customer this past month used 10,000 or more gallons of water totaling 701,800 gallons of water which was 30% of the water sold.
- This month's direct deposit check for the Bank of the West account was \$7,083.94.
- Correspondence in your packets.
 - On October 11 each jurisdiction was invited to attend the Official Logic and Accuracy Test of the voting equipment used for the November 8, 2022 General Election. I attended this test and certified the equipment was working accurately. In your packet is the Certificate of Accuracy signed by every jurisdiction who has in attendance for the test.
 - As you are all aware there is a letter of concern circulating via mail to residents in the area. I
 have provided the Yavapai County Sheriff's office a copy of the letter and they are investigating.
 There is copy of the letter in your packet.
 - o Between October and November we receive two separate payments from American Tower that are direct deposited into our bank account. The first payment for \$105,309.59 was deposited in our account October 19, 2022. A copy of the email notifying us of the payment is in your packet.
 - I created an employee evaluation form for the District to use to when doing employee performance reviews that is based on the Districts expectations of employee growth and job

- performance. There is a copy of the form in your packet. I did have the form reviewed by counsel to ensure there were no questions that could put the District at risk.

7.1.2. Discussion and possible action on the American Rescue Plan Act (ARPA) Grant Projects

Update by Ms. Befort, The Boring crew is still putting in the culverts for the new lines across roadways.

We are required to send out Invitation for Bids (IFB's) for every aspect of this grant that we are asking for reimbursement. Tosca is helping with this like she has with other requests we have sent out. We are kind of at a standstill for any work being started until we get the IFB's out and get the responses.

7.1.3. Discussion and possible action on the waterline across the creek at the Sandfilter Ms. Befort gave an update:

The shoring of the bank was completed this month, thanks to Pioneer and Henrietta Mine, donating more equipment, labor and materials, with the rain we had and Pioneer's equipment being down it took longer than expected. This is still only temporary until the more permanent solution by the USDA – Natural Resources completes their design and the work is completed. From my understanding this could take up to a year to complete which will take us back into monsoons. We did not qualify for the urgent funding which would have been few months. This whole process has taken longer than I expected. But I have been working with several different entities and with the monsoons being over I am looking at long lasting solutions to this and not a temporary fix that we will be dealing with again in the next few years. I am wanting to make sure everything is done correctly and will last for hopefully forever or at the very least 20 – 30 years.

We had our kickoff meeting with Atkins North America on October 17th, they will be doing the structural support design for the waterlines. They have recommended that we leave the current building intact until they are able to come out on site and see how removing it could affect the

support of the waterline. The building does support the waterline spanning approximately 14 feet from the last piling to the edge of the building. Flood control agrees with this because the monsoons are over and the likelihood of catastrophic flooding in the wash is minimal this time of year. We are looking at about 3 months for this engineering to be completed.

Concrete slab – Was completed this week.

New Building – Should be completed tomorrow if he does not complete it tomorrow then we are waiting until December.

Easement – Surveyor was here today doing the survey for the 25' x 25' easement for the building only. I should have the easement back next week for him to sign. The property owner has agreed to that and has been very pleasant to work with. This took longer than expected, by the time I got permission from the property owner, Tom Liuzzo with Granite Basin was out sick with the flu for a week or this would have been completed 2 weeks ago.

7.2. NEW BUSINESS

7.2.1. Discussion and possible action on accepting the employee review of Chris Pomichter and recommended wage increase.

Manager Befort explained she did not include the review in the packet as it is employee related and would become public record. But she did Chris's review and they discussed his goals for the next year and recommended a \$1.00 raise to being him to \$15.00/hours.

Clerk Cocchiola motioned to approve the wage increase, Member Jones 2nds, Member King asked if they also needed to approve accepting the employee review, Counsel Henry stated they did and suggested Clerk Cocchiola amend his motion to include that. 7.2.4. Discussion and possible action on correspondence from anonymous source expressing desire to remove the board members (Joe)

Chairman Mish stated that this has his attention, and these emails are what is causing this stuff. I think it's time that we cease and desist Because I am gonna tell you thats why, I got this letter, please forward to Chairman Joe Mish, My name is Jamie Shannon, it's in respect to purchasing this water company, now you guys at home almost lost this water company twice, if it wasn't for myself and couple of other guys doing our little dance there wouldn't be no Mayer Water today and when we got this kind of stuff going on that's how this comes about and I will read it to you. But since I had an operation on my eyes. I am going to ask the Board Clerk to read it.

Counsel Henry asked a question of the Chairman as to point of order. Inquiring if we were on 7.2.4 or 7.2.5.

Chairman Mish replied both as they are connected.

Counsel Henry again asked if 7.2.4 and 7.2.5 were connected as they are agenized separately and was wondering if we wanted to do 7.2.5 first then 7.2.4

Chairman Mish stated that he received a letter in the mail and showed the public the letter and envelope and that he thinks that everyone knows including Mardi because she called me on it. He has a very serious problem as he doesn't know who these people are and he doesn't really give a crap. But, he takes exception to people who will write a letter and they are so unproud of it that they won't even sign it. If you are that good at it, why don't you sign it.

Member King stated that at this point she is not interested in having a public discussion over an item that is currently being investigated by the Sheriffs department.

America is the land of law, our laws we founded (pointing to Counsel Henry) you will tell them. Back from old English law, which was derived from the Holy Bible, the good book. That letter, prompts me, tomorrow, bright and early, I will be at 7th Street and Deer Valley Road and if anybody doesn't know what's on 7th Street and Deer Valley Road, I will tell you. The Federal Bureau of Investigation. That letter falls under the Patriot Act and if somebody doesn't know what the Patriot Act is I will explain it. It's called Domestic Terrorism. If you wanna hear more I will tell you more. Clerk ask Chairman Mish and Member Jones if they wanted to hear more to which they indicated they did. Could be your next-door neighbor, could be the pastor at your church. That's where they are gonna go first. They are gonna listen to what they got to say, what do you know? What do you think? That's the first move, the second move they are going to come right down here. They are going to investigate every one of us, oh yeah. They are going to investigate every body who has been at this meeting for the last 6 months to a year. How are they going to do that? Modern forensics, What do they call that, face points, on a computer? Turning to Ms. Befort he asked "Did you put these meetings on the web?" Ms. Befort replied, "they're not on the web, no." He stated they would down to see her (Ms. Befort) to get them. They will identify everybody, they will look at your criminal records, they'll pull drivers licenses from Mayer, they will pull drivers licenses from Cortez, Spring Valley, Poland, everybody will be identified. Okay, what's that gonna do? Here's what that is gonna do. There's 3 primary things they look at. A person of interest, that's number 1, number 2 a suspect, and number 3 primary suspect. They will go to a person of interest, they'll knock on your door. Do you got a moment to talk. Don't tell anybody that you talked to us. What do you know? What've you heard? Hmm. If they come to your door take a sigh of relief. You're not a big suspect anymore. Then from there they will. (inaudible) They may take their time. Remember something, the die has been cast. Time is on their side and by the way there is not statute of limitations on that. If they talk to you. The Feds, tell them the truth, whatever you do, do not lie to them, if you lie to them, oh God help you if you don't believe me. Ask Hunter Biden, he'll tell you. A panel of the grand jury because they keep hearing the same name over and over again, the grand jury will hand down an inditement. That came through the post office. He then asked Ms. Befort how many letters she knows of. Ms. Befort replied 4. Clerk Cocchiola stated that will be 4 counts alone if there's 10 there will be 10, if there's 50 there will be 50, if there 100 there's 100, if there's 1000 there's 1000 counts right there. Then he will charge you as he goes on. You will get indited. I'm seeing at least 4 counts on this. (referring to the letter) Each count, 10 years, sometimes up to a \$250,000 fine for each count. These idiots or idiot, whatever, I love this, right here, (picks up the letter and reads) "We have been to your meetings", What do you think they are gonna do? They are gonna look up everybody that has been to the meetings. They will leave no stone unturned. They want to know. Why? What? Federal Bureau of Investigation is nothing to fool with. So I think they deserve the best. At the bottom of this letter this, "Watch and

Clerk Cocchiola, probably wouldn't want to live on the difference.

Chairman Mish well anyway, I don't think they want to discuss it. They want to remove all Board members.

Clerk Cocchiola, yeah.

Chairman Mish, I guess we will just go and see where it goes.
