6. ADMINISTRATION/STAFF REPORTS

- 6.1. Manager's Report By Frank Soto
 - 4 blue stakes as of November 18, 2021
 - Sent the meter for account 151 to be tested at the request of the property owner. Meter tested 94% at low flow. Customer still denies having an issue with their plumbing and is accusing the District of not reading the meter correctly and or not reading the meter at all.
 - Chimney Ranch trailer park hook-up is still on hold due to change in ownership. Lonnie(park manager) is piled under tons of paperwork.
 - Bureau of Land Management (BLM) permit has been approved for the Racetrack Well project. This was quite an experience and would still not be done if it weren't for the time and effort of Mike Rice.
 - Josh Green smashed his hand driving a grounding rod at the Sand Filter
 - Chris Pomichter was bit by a dog while meter reading. Sheriff's office was called, and the dog was picked up. The dog was not up to date on his shots. At this time Chris does not need to get the rabies shots as the dog is being observed.
 - We need to replace the rear tires on the backhoe soon.
 - Arizona Department of Environmental Quality (ADEQ) has reduced the monitoring requirements for TThM's and HAA5's
 - County grant won't be decided on until maybe March or April 2022.
 - Approved by APS to proceed with electrical panel at the Sand Filter. Conduit is in and
 waiting on electrician to install meter panel. They apologized as they have been very
 busy with new construction.
 - Mardi is doing a very good job and will be getting another raise due to her performance.
 - Please follow the chain of command. I am always open to talk either in person or by phone.

6.2. Office Report - By Mardi Befort

- 1. Water Turn Off's/Past Due Account
 - a. We had 13 customers scheduled to be shut off this month.
 - i. 10 paid the day of shut off or made payment arrangements with Angie
 - ii. 3 were turned off, they have all paid in full and have been turned back on.
 - b. For November bills we have 78 past due account, bills will be mailed out tomorrow.

2. Website usage

a. In the past 30 days our website has had 1029 views (refers to the number of times the website has been visited) and 194 unique visits (Actual number of people who have visited the website). Example: if a customer goes onto our website 10 times in 1 day it will show there are 10 views and 1 unique view.

3. Water usage this month

- a. We were able to read meters in 2 days this month. It would have been done in 1 day had Chris not been bitten by a dog. Frank and Chris read meters on Monday Nov 15, Chris and I read meters on Tuesday Nov 16.
- b. This month we pumped 2,497,800 gallons of water which is 127,300 more gallons than last month
- c. We sold 2,178,700 gallons of water this month which is 33,400 gallons more than last month.
- d. This month we had a water loss of 12.78% compared to 9.50% last month
- 4. American Tower deposit (which is the 2^{nd} deposit) in the amount of \$25,073.66 was made 11/01/2021.

This month's direct deposit check for the Bank of the West account was \$3,531.40, this is far less than last month because our meeting is a month earlier and only 1 payroll since the last Board meeting.

We are able to move forward with the project.

- 7.2.4. Discussion and possible action on adding meter policy to Rulers and Regulations regarding request for larger meter. (Mardi/Frank)Ms. Befort read the policy aloud.

"The standard size meter installed at a residential home will be a $5/8" \times 3/4"$ or 3/4" size meter. If a Water District customer requests a larger size meter than the standard size, a written Request form (available at the District office and on the District Website) must be submitted to the District, by the property owner, documenting the need for the larger size meter. All written requests will be reviewed by the Manager, and a written response will be provided within 30 days of receipt by the District. All costs related to the application, including, but not limited to, engineering analysis, are to be borne by the applicant. The District reserves the right to approve or deny any submitted request for a meter larger than the standard size meter"

Clerk King asked if we wanted to add something with regards to anyone wanting a smaller meter.

Ms. Befort said that her and Ms. Henry would work on revising the policy and bring it back to the next Board meeting.
