 - 4 blue stakes
 - Roof is almost done at rental
 - Member Mish and Manager Soto met with county road people and they
 are planning on doing some work on main street within the next year or
 2 and are also going to be doing some work on central but don't have a
 date for that
 - Closed the rental account with Bank of the West
 - \$887 with the County Road Department that can be used towards permits on any road work that we do.
 - Purchased a generator. It's up and running
 - Fixed the safe, we got the code but it wouldn't close, Emanuel fixed it and we can use it.
 - Met with Fire Chief for the District, went to the tower, Frank had

originally negotiated a generator for the location, it has not been used in years. Fire District does not want it and said the District could have the generator.

- We have been running the Terrell wells #1 and #2, is not producing as well as we hoped. But it does produce some water 4-8 gallons a min.
- Booster runs constantly up to Poland.
