SPECIAL BOARD MEETING SUNDAY OCT. 25 1998 MINUTES

- 1. Chairman Mike Schuhmacher called meeting to order at 2:10 PM.
- 2. Members present: Mike Schuhmacher, Johnnye Hines and Dick Diffenderfer. Walt Diskin and Jerry Bonno were both absent.
- 3. Public present: Lavonne Becker, Jerry Becker, Helen Price, John M. Watkins, and Duane Hines, Mike King, Allen Sullins and Buddy Pomichter.
- 4. Chairman Mike Schuhmacher opened the meeting for public questions and Concerns on the up coming bond election.
 - A. Mr. Watkins at that time told the board that they would not get away with pushing Bond onto the people of Mayer, and that the bond would never pass. He then stated that the Water District had no business making the people of Mayer Pay for the relocation of the lines with the highway-widening project so as to serve The 50 customers in Poland Junction. Mike Schuhmacher tried to respond to Mr. Watkins statement but was continuously interrupted by Mr. Watkins.
 - Mr. Watkins also stated at this time that the District had no business going into A project with A.D.O.T. and that they were to corrupt to have any dealings with. He also will contact the Attorney General Monday because of the profit and loss. He would at that time inform the Attorney General that there was corruption and Embezzlement going on in the District.
- B. Mrs. Helen Price left the meeting at this time stating that she had not attended the meeting to listen to Mr. Watkins or to tolerate his rude behavior.
- C. Mr. Watkins continued his rude interruptions when asking a question he would not Allow a response from the Board Members.
- D. Because of his continued bad behavior Chairman Mike Schuhmacher asked Mr. Watkins to please leave the meeting. When leaving Mr. Watkins stated that we would be hearing from his lawyer as well as the Attorney General.

- C. Mike King: He taught school in Mayer for 10 years. He has some back ground in ground water systems. He would also like to see the District settle completely with Mr. Albins, note wise as well as agreements on meters.
- **D.** Allen Sullins: He is experienced in water systems, he also has concern with the many improvements needed in the Water District. He also has experience as a heavy equipment operator.
