

MAYER DOMESTIC WATER IMPROVEMENT DISTRICT
SPECIAL BOARD MEETING
SEPTEMBER 27, 1998

1. **CALL TO ORDER**-THE CHAIRMAN CALLED THE MEETING TO ORDER AT 2:04 P.M.
2. **ROLL CALL OF MEMBERS**-PRESENT WERE MIKE SCHUCMACHER, WALT DISKIN AND JOHNNYE HINES. ABSENT WERE DICK DIFFENDERFER AND JERRY BONNO.
3. **DISCUSSION OF POSSIBLE RURAL DEVELOPMENT LOAN**-MIKE TOLD A LITTLE ABOUT THE LOAN. FRANK THEN TOLD ABOUT THE DIFFERENCE IN INTEREST RATES AND MONEY THAT WOULD BE SAVED WITH THE LOAN. THE LOAN AND AMERIZATION WITH THE ABLINS WOULD BE 7 $\frac{1}{2}$ % AS THE RD LOAN WOULD BE 4%. THE BOND WOULD BE A REVENUE BOND AND WOULD BE PAID BACK WITH THE MONEY FROM THE SALE OF WATER. IT WOULD NOT BE ATTACHED TO THE PROPERTY IN ANY WAY. A LOT OF QUESTIONS WERE ASK BY THE PUBLIC. THE PUBLIC WANTED TO KNOW WHY THE WATER COMPANY WAS BOUGHT IN THE FIRST PLACE. THAT WAS EXPLAINED AS THE ALBINS WANTED TO SELL IT AND IF IT WENT TO ANOTHER PRIVATE PARTY THE PUBLIC WOULD HAVE NO SAY IN THE RATES OR THE WAY IT WAS MANAGED.
4. **MEET THE CANDIDATES**-THE CANDIDATES ARE JOHNNYE HINES, MIKE KING AND RAYMOND (BUDDY) POMICHTER. EACH CANDIDATE TOLD A LITTLE ABOUT THEMSELVES AND WHY THEY WANT TO BE ON THE BOARD. THE PUBLIC THEN ASK EACH ONE QUESTIONS.
5. **COMMENTS**-THE QUESTION WAS ASKED AOUT THE CHEMICALS THAT ARE PUT IN THE WATER. ONLY CHLORINE. FRANK THEN SPENT ABOUT TEN MINUTES TELL THE PUBLIC SOME OF THE THINGS THAT COME UP WHILE MANAGING THE DISTRICT. THE DISTRICT RECENTLY RECEIVED A GRANT OF \$8000 FROM THE DEPARTMENT OF COMMERCE TO REFURBISH WELLS.
